

Declaration & Deed of Conditional Express Trust & Withdrawal of Consent to Mandatory Taxation

Preamble

1. I discovered recently that Britain has taken part in 84 illegal wars since 1946. Since 2001, British taxpayers have contributed more than £2 trillion¹ in taxes to Parliament which HM Government has used **to fund, support or wage 10 illegal criminal wars** in Afghanistan, Iraq, Libya, Syria, Palestine (Gaza), Lebanon, Yemen, Ukraine, Russia and Iran.
2. As a direct result of our taxes financing these illegal wars, UK taxpayers have funded the murder of 2.5M adults and 1M children, we've injured many more, taken part in the destruction of homes, livelihoods, hospitals and community infrastructure, and we've driven 25M men women and children into exile and destitution. These are the worst crimes ever committed by Britain's leaders and taxpayers, and **they must be stopped**.
3. Not one of our victims was allowed the opportunity to defend themselves and their family in court or to plead for mercy before they were summarily attacked, injured or killed by order of Britain's political, civil, military and corporate leaders funded in part by my taxes.
4. After studying the laws governing the funding of war I discovered that it is a serious crime for taxpayers to pay or collect tax if we know that the money may be used for criminal purposes of war. I also discovered that I can be prosecuted and imprisoned for 'conduct ancillary to genocide' if I continue to pay tax to the UK Government or its agents, knowing that the money will be used in part to fund war, terrorism, mass murder and genocide.

Trust Purposes and Objects

5. So I decided that never again will I willingly fund illegal warfare and the worst crimes known to mankind. To this end **I hereby withdraw my consent** to mandatory taxation and declare that **I will take no further part in funding criminal acts of UK Governments**.
6. To these ends and in accordance with the **Law of England & Wales** and the **Recognition of Trusts Act 1987**, I have transferred, and will continue to transfer into trust, sufficient funds for my trustee to settle all amounts purportedly payable to Parliament, Governments, local Councils, HMRC, HMCTS (Courts), businesses, landlords, banks or their agents (hereinafter jointly and severally known as the **Primary Beneficiary**) by way of their ending all criminal acts of war, terrorism and genocide and obeying the laws of war and peace as well as meeting all my conditions (para 7 below) before 05/04/2027.

Trust Conditions

7. As **settlor** and **trustee** of this trust I shall pay all lawful taxes and debts owed to the **Primary Beneficiary** within 28 days of receiving documented proof from the Attorney General, the High Court or a court of competent jurisdiction confirming that:
- Money paid to the Primary Beneficiary in lieu of taxes, fees, fines, interest or debts **is expressly excluded by law from the offences** in sections 15 – 18 of the Terrorism Act 2000 and section 52 of the International Criminal Court Act 2001,
 - The Primary Beneficiary's involvement in warfare, acts of terrorism, genocide and their funding has ended and all UK military forces have returned to their UK bases;
 - New laws and rules have been put in place to ensure that no Minister, MP, Military commander, Crown agent, law enforcement officer or taxpayer can breach the **UN Declaration on Principles of International Law** or the laws of war and peace;
 - Criminal proceedings have begun against those responsible for starting, supporting or funding the illegal wars, murders and genocides that have taken place since 2001.
 - I am guaranteed, both now and in perpetuity, full immunity from prosecution in respect of all alleged offences arising from the non-payment of taxes prior to the termination date of this trust (05/04/2027).

Failure to meet Trust Conditions

8. If the Primary Beneficiary fails to meet these Trust conditions, I as **Trustee** and **Secondary Beneficiary** of this Trust will inform the Primary Beneficiary that their claim to my money is rescinded and nullified on the grounds that the funds would have been used for criminal purposes, and I will transfer the trust assets to the **Secondary Beneficiary** within 14 days.

Statement regarding this Conditional Trust

This statement clarifies the purpose and structure of this trust which is established to hold funds that would otherwise be payable as taxation. The funds have been placed into a private trust which exists solely for the purpose of safeguarding my funds pending legal clarification regarding their potential use for unlawful or criminal purposes. The trust is temporary and conditional upon clarification and settlement of the concerns raised in paragraph 7 above. This trust is established in good faith and reflects a responsible attempt to balance my civic obligations with the duty of citizens to ensure they do **not knowingly fund** or participate in unlawful or criminal activity.

Extracts of Law Governing War and its Funding

In 1946 the **Nuremberg War Crimes Tribunal** held that:

*War is essentially an evil thing. Its consequences are not confined to the belligerent states alone, but affect the whole world. **To initiate a war of aggression therefore, is not only an international crime, it is the supreme international crime** differing only from other war crimes in that it contains within itself the accumulated evil of the whole.*

Crimes against international law are committed by men, not by abstract entities, and only by punishing individuals who commit such crimes can the provisions of international law be enforced.

In 1970 the UN issued and Britain ratified the **Declaration on Principles of International Law** governing relations between States. Two of its 42 guiding principles stipulate:

*No State or group of States has the right to intervene, directly or indirectly, for any reason whatever, in the internal or external affairs of any other State. **Armed intervention and all other forms of interference** or attempted threats against the personality of the State or against its political, economic and cultural elements **are in violation of international law**;*

*By virtue of the Principle of equal rights and self-determination of peoples enshrined in the Charter of the United Nations, **all peoples have the right freely to determine, without external interference, their political status** and to pursue their economic and cultural development, and every State has the duty to respect this right in accordance with the provisions of the Charter.*

In 2000 Parliament ratified the international **Terrorist Financing Convention** by enacting the **Terrorism Act 2000** in which it ruled that:

1. *Terrorism is the threat or use of firearms or explosives endangering life for a political cause,*
17. ***A person commits an offence if he enters into or becomes concerned in an arrangement as a result of which money or other property is made available to another, and he knows or has reasonable cause to suspect that it will or may be used for the purposes of terrorism.***

In 2001 the UK Government ratified the **Rome Statute of the International Criminal Court** by enacting **the International Criminal Court Act 2001**. This Act stipulates that:

51. *It is an offence against the law of England and Wales for a person to commit **Genocide, a crime against humanity or a war crime.***
52. *It is an offence against the law of England and Wales for a person to engage in **conduct ancillary to genocide, a crime against humanity or a war crime.***
55. ***Meaning of "ancillary offence".** References to an ancillary offence ... are to—*
 - (a) *Aiding, abetting, counselling or procuring the commission of an offence,*
 - (b) *Inciting a person to commit an offence,*
 - (c) *Attempting or conspiring to commit an offence, or*
 - (d) *Assisting an offender or concealing the commission of an offence.*
78. ***This Act binds the Crown** [the Government] **and applies to persons in the public service of the Crown,** and property [money, taxes, weapons, supplies etc.] held for the purposes of the public service of the Crown, as it applies to other persons and property.*

In a tyranny tax is mandatory, in a democracy tax is voluntary

Notes to assist a Settlor to complete this Taxation & Debt Trust Deed

This Declaration and Deed of Trust, when completed, signed and witnessed is your legal, lawful, legitimate Trust. When this completed Deed, together with the first payments (cash and/or cheques and/or promissory notes) of your alleged tax and debts have been paid to the trustee and your Primary Beneficiaries have received a copy of the Trust Deed (so that they know the conditions that they have to meet to receive payment), your conditional taxation trust is set up and fully operational. You have now **settled your taxes / debts** into a trust and you cannot get the money back if the **Primary Beneficiary** meets the Trust conditions. **The money in trust no longer belongs to you, it belongs to your Trustee** until the trust end date when it must be paid either to the **Primary** or to the **Secondary Beneficiary**.

If the **Primary Beneficiary** fails to meet all the trust conditions by the termination date of the Trust [April 5th] then you as Trustee are bound by trust law and the conditions of the Trust to transfer the money to the **Secondary Beneficiary** (you as settlor). If you want any other person or organisation to be a Secondary Beneficiary, such as a relative or friend or **No Tax For War, Make War History** or **HOPE Sussex**, add a signed addendum to your Deed (witnessed by a friend) with their details and the amount you wish them to receive.

Two important principles govern this trust process. **First: IN A DEMOCRACY** (government of the people by the people for the people) **YOU ARE SOVEREIGN**. A sovereign person is one that independently controls their own thoughts, speech, actions and destiny. It is **not** Parliament, the Government, the Prime Minister, the Monarch, Councils or Judges that are sovereign, It is **YOU**. You decide how to spend your money. **In a tyranny tax is mandatory, but in a true democracy tax is voluntary**. In future only give your money and taxes to people and activities of which you approve.

Second: Taxes (your money) must be used **SOLELY** for lawful purposes and **NEVER** for criminal purposes that cause harm to any human being. This means that if you pay money/taxes to any other individual, business, institution or Government agent knowing that some of it may be used in future for purposes of war, terrorism, war crimes, mass murder or genocide, you commit a serious criminal offence for which you can be prosecuted and imprisoned for 'aiding and abetting genocide'. So always check before you pay money to any other person or organisation, that all of it will be used **SOLELY** for beneficial purposes and **NONE** of it for harmful, illegal, unlawful or criminal purposes.

Currently there are no tax collectors, public officials, lawyers or law enforcement authorities in Britain who know and understand these two principles. So if a tax collector, council, bank or court claims that none of the money goes for war or the illegal purposes of terrorism, inform them of their error and the meaning of the criminal laws of war. They need to know that all taxes (including Council tax), fines, fees, student loan repayments etc. are credited to HM Government's Consolidated Fund **before** being granted to Councils and Ministries and that at least 15% of your taxes will be used by UK Governments to fund past, current or future wars and the genocide of men women and children [we've murdered on average 145,000 people each year since 2001]. We should rename the MoD to reflect its true role as the **Ministry of Offence** or more accurately the **Ministry of War, Mass Murder and Genocide**.

Lastly, be reassured that while Governments use taxpayers' money for criminal purposes, **you have an international and domestic legal duty** to withhold all money from the Government and/or its' agents if you know or suspect that it may be used directly or indirectly in whole or in part for criminal purposes. So there really is nothing to be lost and everything to be gained by paying all taxes and debt payments into your lawful taxation trust. When lots of us stand up to government and bankers tyranny, we can end war and genocide within weeks, and use our money instead to create a truly democratic, fair, just and peaceful world. What a wonderful legacy to pass on to future generations.
